Purchases made during one month are due and payable by the 10th of the following month. Those accounts which have discounts applied **must** be paid by the 10th of the month following purchase for discounts to be allowed. Invoices which are not paid in 30 days are subject to a monthly finance charge of 1.5 percent per month. This is an annual percentage rate of eighteen (18) percent.

Invoices not paid within 60 days will place the account on COD (cash on delivery) basis. An account which is not paid within ninety (90) days of purchase is, at the Company's option, relinquished to an agency for collection or the Company will exercise its lien rights. Purchaser hereby agrees to pay either the collection fees assessed, or reasonable attorney's fees and court costs in the event of default of Purchaser.
